Writ petition (public interest litigation) praying that in the circumstances stated in the affidavit filed along with the WP(PIL) the High Court be pleased to

a. Issue a Writ of Mandamus or any other appropriate writ, direction, or order directing the 1st Respondent – Bar Council of Kerala – to forthwith initiate action under Section 35 of the Advocates Act, 1961 against all advocates named in the RTI-disclosed List of Advocates Who Have Not Passed the AIBE Exam (18.05.2026, Exhibit P6), suspend their enrolment/right to practice pending enquiry, and complete the disciplinary process within a time-bound period as this Hon'ble Court may fix;

b. Issue a Writ of Mandamus or any other appropriate writ, direction, or order directing the 1st Respondent to publish, within four (4) weeks, on its official website the complete and updated list of advocates currently enrolled with the Bar Council of Kerala who have not passed the AIBE and do not hold a valid Certificate of Practice, and to update such list on a quarterly basis thereafter;

c. Issue a Writ of Mandamus or any other appropriate writ, direction, or order directing the 1st Respondent to issue a circular to all Presiding Officers/Judges of all courts in the State of Kerala – including High Court, District Courts, Family Courts, Civil Courts, Criminal Courts, and Magistrate Courts – enclosing the said list and directing them to verify the credentials of advocates appearing before them;

d. Issue a Writ of Mandamus or any other appropriate writ, direction, or order directing the 2nd Respondent – Bar Council of India – to exercise its supervisory jurisdiction and issue appropriate directions to the 1st Respondent to enforce compliance with Sections 17 and 24 of the Advocates Act, 1961, and to frame a standard operating procedure for periodic verification of AIBE clearance and Certificate of Practice status across all State Bar Councils;

e. Issue a Writ of Mandamus or any other appropriate writ, direction, or order directing the 3rd and 4th Respondents – NALSA and KELSA – to immediately review the credentials of all advocates empanelled on their legal aid panels in Kerala, remove from such panels any advocate who has not cleared the AIBE and does not hold a valid Certificate of Practice, and notify affected legal aid beneficiaries;

f. Direct the 1st Respondent to file a status report before this Hon'ble Court within six (6) weeks disclosing: (i) the total number of advocates currently enrolled with the Bar Council of Kerala who have not passed the AIBE; (ii) the number of disciplinary complaints pending relating to AIBE non-clearance/absence of Certificate of Practice; and (iii) the action taken, if any, in respect of each such complaint;

g. Pass such other order(s) or direction(s) as this Hon'ble Court may deem fit and proper in the interests of justice, the rule of law, and the protection of litigants across the State of Kerala.

This petition again coming on for admission upon perusing the petition and the affidavit filed in support of WP(PIL), this Court's order dated 22/07/2026 and the court passed the following:

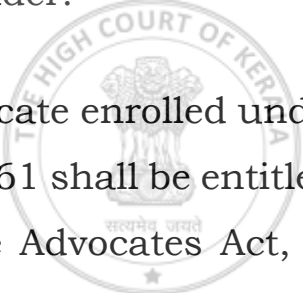
ORDER

Soumen Sen, C.J.

This Public Interest Litigation is filed alleging inaction on the part of the Bar Council of Kerala in not following the Rules and the provisions of the Advocates Act, 1961, in permitting Advocates to practise without a certificate of practice.

2. Learned counsel for the Bar Council of Kerala has

submitted that presently, the Bar Council of Kerala has not been constituted and the earlier Committee appears to have not taken any steps to identify the Advocates who have not participated in the All India Bar Examination, which is a prerequisite for a certificate of practice being issued upon being successful in the said examination pursuant to the amendment to Part VI, Chapter III, Rule 9 of the Bar Council of India Rules, which has come into operation from 18th June 2010. The said Rule is set out hereunder.



“9. No advocate enrolled under section 24 of the Advocates Act, 1961 shall be entitled to practice under Chapter IV of the Advocates Act, 1961, unless such advocate successfully passes the All India Bar Examination conducted by the Bar Council of India. It is clarified that the Bar Examination shall be mandatory for all law students graduating from academic year 2009-2010 and onwards and enrolled as advocates under Section 24 of the Advocates Act, 1961.”

3. The Bar Council of Kerala has given a list of 1157 Advocates from July 2010 to December 2021 who have not passed the All India Bar Examination. We have been informed

that an Ad hoc Committee has been constituted under Section 48B of the Advocates Act, 1961. The Ad hoc Committee shall file a report by the adjourned date as to whether these 1157 Advocates have applied for a certificate of practice. In the event it is found that they are practising without any such certificate of practice, appropriate notice shall be issued to such Advocates. The Ad hoc Committee shall publish on the website of the Bar Council of Kerala the list of defaulting Advocates on or before 20th August 2026 and ensure follow-up action in terms of Rule 18 of the Certificate and Place of Practice (Verification) Rules, 2015.

4. The Registry of the High Court and all the District Courts is directed not to register any matter in which these 1157 Advocates have filed their Vakalathnama. In the event it is found that any of these disqualified Advocates have filed the Vakalathnama, there should be a proper endorsement in the file for the benefit of the Bench. The Registrar (District Judiciary) shall immediately communicate this list of 1157 candidates to all the learned District Judges for information and compliance. However, if it is found that any of the

Advocates in the meantime have obtained the certificate of practice, their names shall be deleted from the list, provided they file an authentic copy of such certificate of practice.
