of 232 Advocates – Request for necessary action – Reg.**

The Bar Council of Kerala had published, on 13.05.2025, a list of 1157 advocates who had not passed the All India Bar Examination (AIBE) during the period from 01.07.2010 to 21.12.2021.

The Hon'ble High Court of Kerala, by order dated 19.08.2026 in W.P.(C) No.147/2026, *Amarnath Joshi Surendiran v. Secretary, Bar Council of Kerala & Others*, directed the Registrar (District Judiciary) to communicate the said list to all the learned District Judges for information and compliance. The Hon'ble Court also directed that the names of advocates who subsequently obtained a Certificate of Practice be deleted from the list, subject to production of an authentic copy of the Certificate of Practice.

The Hon'ble Court, in its subsequent order, further directed that, upon receiving intimation from the Bar Council of Kerala, the Registrar (District Judiciary) shall intimate the learned District Judges, who shall act accordingly.

In compliance with the said directions, the Bar Council of Kerala has prepared a list of 232 Advocates who have subsequently qualified in the All India Bar Examination after publication of the list dated 13.05.2025. The said list is forwarded herewith.

It is therefore requested that the list of 232 advocates may kindly be communicated to all the learned District Judges concerned, with a request to delete/remove their names from the earlier list of 1157 Advocates, in accordance with the directions of the Hon'ble High Court.

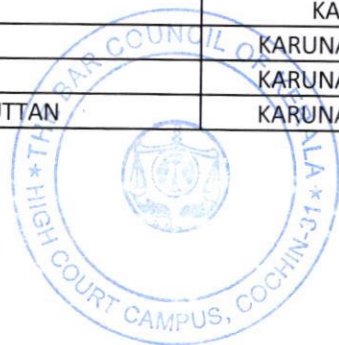

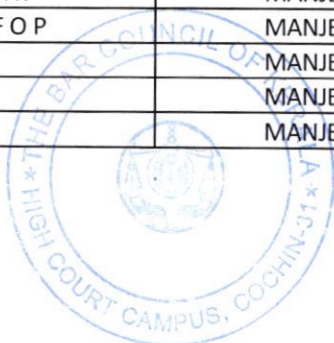
